NARRATIVE SUMMARY

During November, the 4th Battalion, 12th Marines retained the primary mission of General Support of 3d Marine Division. Again it provided "Quick Fire Channels" to three Direct Support Battalions, and in addition, the battalion assumed the responsibility of providing reinforcing fires for the ARVN at DIE MARKER bunker site C-1. These unofficial reinforcing roles accounted for the large number of observed missions, with minimum response time. Additionally, the battalion assumed tactical fire direction of the First 8" Howitzer Battery, with platoons located at GIO LINH, the ROCKPILE, and CON THIEN. The battalion also assumed the role of providing fires for defense of the QUANG TRI Combat Base. Direct support fires were also provided to 65 Reconnaissance Teams.

Until the 21st, the battalion controlled the General Support fires in the Scotland II (4th and 9th Marines) and Lancaster II (3d and 9th Marines) A.O.'s. Also, on the 21st the battalion relinquished control of the 1st 8" Howitzer Battery.

The tactical and technical fire direction of the three organic batteries and the tactical fire direction of the 1st 8" Howitzer Battery were centrally controlled in the battalion fire direction center located at CAMP CARROLL; however, on the 22d Lima/4/12 established a fire direction center at the ROCKPILE. Tactical fire direction is still maintained by battalion as well as the capability of maintaining technical fire direction. This again provided the battalion with the capability of massing fires instantaneously over a wide front.

On the 2d, Mike/4/12 displaced three guns from CON THIEN to DIE MARKER bunker site C-2. On the 3d, Mike/4/12 displaced three guns from DIE MARKER site C-2 to DONG HA.

On the 4th, Lima/4/12 displaced two guns from the ROCKPILE to CA LU to reinforce 2/12 and 3/12; in addition, Kilo/4/12 displaced from A-3 to DIE MARKER site C-1. On the 11th, Lima 4/12's two guns at CA LU returned to the ROCKPILE.

On the 23d, Kilo/4/12 displaced two guns from DIE MARKER bunker site C-1, to DONG HA. Mike/4/12 displaced from DONG HA to DIE MARKER bunker site C-2 on the 4th.

In the course of the month, this battalion controlled the tactical fire direction of as many as six firing batteries and the technical fire direction of three. General Support fires for the entire Division were provided in a timely and accurate fashion.
